11. To confer Awards for outstanding work done by students through an industry of the Association.


Both may participate and be invited to seminars/ workshops/ conferences, organized by other party.

Cooperation and development of activities may extend to any fields and subjects in which Institute and industry may identify shared interest


Both the parties recognize that this Memorandum of Understanding establishes a foundation of mutual understanding and interest and does not in itself entail any **financial obligation for either party.**
